PAYMENT & FEE POLICY

OUR FEE AND PAYMENT POLICY IS DESIGNED WITH CONVENIENCE IN MIND, ENSURING A SMOOTH AND HASSLE-FREE EXPERIENCE FOR OUR ATHLETES AND THEIR FAMILIES.

INVOICING AND PAYMENTS

ALL FEES WILL BE CHARGED VIA DIRECT DEBIT EACH MONTH OR CAN BE PAID UPFRONT AT THE START OF THE YEAR. ALL CUSTOMERS MUST CONFIRM THEIR DIRECT DEBIT WITHIN A WEEK OF THEIR ENROLMENT CONFIRMATION. IF YOU WISH TO PAY UPFRONT OR VIA CASH, PLEASE CONTACT OUR ADMIN TEAM DIRECTLY.

OUTSTANDING FEES AT OTHER SCHOOLS

PLEASE NOTE THAT WE WILL NOT ACCEPT ENROLMENT FOR ANY STUDENT WHO HAS OUTSTANDING FEES AT OTHER SCHOOLS OR SPORTING ORGANIZATIONS. ALL FEES MUST BE SETTLED IN FULL BEFORE ENROLMENT WITH JUNGLE CATS CAN BE CONFIRMED. THIS ENSURES FAIRNESS AND THAT OUR PROGRAMS REMAIN ACCESSIBLE TO ALL ATHLETES.

7-DAY CHANGE OF MIND POLICY FOR UPFRONT PAYMENTS

IF YOU CHOOSE TO PAY UPFRONT AND CHANGE YOUR MIND, WE OFFER A 7-DAY CHANGE OF MIND POLICY. SHOULD YOU DECIDE TO WITHDRAW WITHIN 7 DAYS OF MAKING THE UPFRONT PAYMENT, 80% OF THE FEES WILL BE REFUNDED, WITH THE REMAINING 20% RETAINED TO COVER ADMINISTRATION COSTS. PLEASE NOTE THAT THIS POLICY DOES NOT APPLY TO DIRECT DEBIT PAYMENTS. PAYMENTS WILL BE CANCELLED AS SOON AS WE RECEIVE WRITTEN CONFIRMATION OF MEMBERSHIP CANCELLATION.

PAYMENT REMINDERS

WE UNDERSTAND THAT LIFE GETS BUSY, AND SOMETIMES IT'S EASY TO LOSE TRACK OF PAYMENT SCHEDULES. TO ASSIST, WE HAVE IMPLEMENTED A FRIENDLY REMINDER SYSTEM:

- **FIRST REMINDER:** IF A DIRECT DEBIT PAYMENT FAILS, A REATTEMPT WILL TAKE PLACE WITHIN 24 HOURS.
- **SECOND REMINDER:** IF PAYMENT IS STILL UNSUCCESSFUL, AN EMAIL REMINDER WILL BE SENT.
- **THIRD REMINDER:** A TEXT MESSAGE WILL FOLLOW IF NEEDED.

IN THE RARE INSTANCE THAT A PAYMENT REMAINS OUTSTANDING AFTER THESE REMINDERS, WE AIM TO MAINTAIN OPEN COMMUNICATION. WE BELIEVE IN WORKING TOGETHER TO ENSURE THAT EVERYONE REMAINS ON THE SAME PAGE AND THAT FINANCIAL MATTERS DO NOT BECOME A BARRIER TO PARTICIPATION. THIS POLICY ISN'T ABOUT PENALISING BUT ABOUT FAIRNESS AND ENSURING EVERYONE CAN FOCUS ON THEIR PASSION FOR JUNGLE CATS WITHOUT UNNECESSARY FINANCIAL STRESS.

CANCELLATION POLICY

POLICIES

AT JUNGLE CATS, WE ARE COMMITTED TO FOSTERING A POSITIVE, RESPECTFUL, AND SUPPORTIVE ENVIRONMENT FOR ALL OUR ATHLETES, COACHES, AND FAMILIES. THE FOLLOWING CODE OF CONDUCT OUTLINES THE BEHAVIOR WE EXPECT BOTH ON AND OFF THE TRAINING FLOOR, INCLUDING ONLINE INTERACTIONS THROUGH SOCIAL MEDIA.

BEHAVIORAL EXPECTATIONS:

- 1. RESPECT FOR OTHERS:** TREAT FELLOW ATHLETES, COACHES, AND STAFF WITH RESPECT, KINDNESS, AND UNDERSTANDING. DISCRIMINATION, BULLYING, OR HARASSMENT OF ANY KIND WILL NOT BE TOLERATED.
- 2. INTEGRITY AND HONESTY:** BE HONEST IN ALL INTERACTIONS. UPHOLD THE VALUES OF TRUST AND INTEGRITY AT ALL TIMES. THIS INCLUDES BEING TRANSPARENT ABOUT ATTENDANCE, TRAINING COMMITMENTS, AND ANY ISSUES THAT MAY AFFECT YOUR PARTICIPATION.
- 3. RESPONSIBILITY:** TAKE RESPONSIBILITY FOR YOUR ACTIONS BOTH INSIDE AND OUTSIDE OF TRAINING SESSIONS. ADHERE TO ALL RULES AND POLICIES, INCLUDING ATTENDANCE, HEALTH, AND SAFETY GUIDELINES.
- 4. TEAMWORK AND SUPPORT:** CHEERLEADING, DANCE & AEROBICS ARE A TEAM SPORT, AND WE EXPECT ALL ATHLETES TO FOSTER A SENSE OF TEAMWORK. HELP AND ENCOURAGE YOUR TEAMMATES TO ACHIEVE THEIR BEST. THE SUCCESS OF THE TEAM DEPENDS ON THE DEDICATION OF EVERY INDIVIDUAL.
- 5. SPORTSMANSHIP:** ALWAYS DEMONSTRATE GOOD SPORTSMANSHIP, WHETHER YOU ARE PARTICIPATING IN TRAINING, COMPETITIONS, OR INTERACTING WITH OTHERS. CELEBRATE WINS GRACIOUSLY, AND HANDLE LOSSES WITH RESPECT AND HUMILITY.
- 6. DRESS CODE:** ADHERE TO THE DRESS CODE FOR TRAINING, COMPETITION, AND OTHER EVENTS. THIS INCLUDES WEARING THE CORRECT UNIFORM AND EQUIPMENT AS SPECIFIED BY YOUR COACHES.
- 7. PUNCTUALITY:** ARRIVE ON TIME FOR ALL SCHEDULED TRAINING SESSIONS, EVENTS, AND MEETINGS. BEING PUNCTUAL SHOWS RESPECT FOR YOUR TEAM AND COACHES.
- 8. HEALTH AND WELL-BEING:** PRIORITIZE YOUR HEALTH AND WELL-BEING BY MAINTAINING A HEALTHY LIFESTYLE AND REPORTING ANY INJURIES OR HEALTH CONCERNS PROMPTLY TO YOUR COACHES.





POLICIES

SOCIAL MEDIA CODE OF CONDUCT

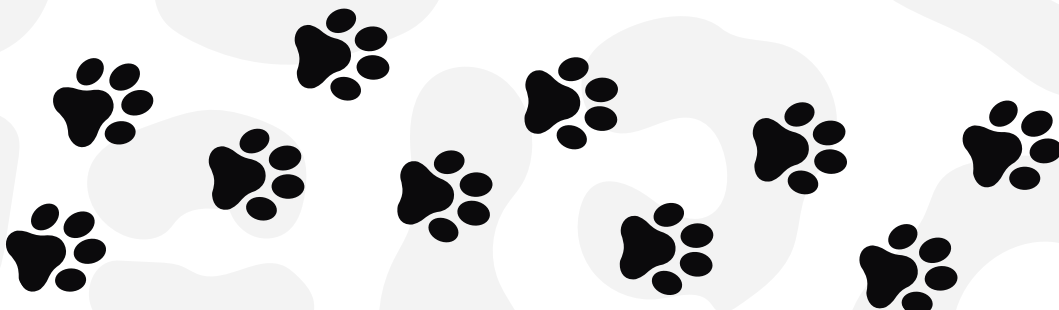
SOCIAL MEDIA IS A POWERFUL TOOL, BUT IT ALSO COMES WITH A RESPONSIBILITY. THE FOLLOWING GUIDELINES ARE IN PLACE TO ENSURE A POSITIVE ONLINE PRESENCE FOR JUNGLE CATS ATHLETES AND THEIR FAMILIES.

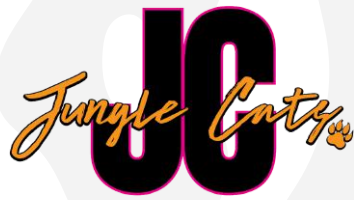
- 1. POSITIVE REPRESENTATION:** ALWAYS REPRESENT JUNGLE CATS IN A POSITIVE LIGHT ON SOCIAL MEDIA. YOUR POSTS, COMMENTS, AND PHOTOS SHOULD REFLECT THE VALUES OF RESPECT, INTEGRITY, AND TEAMWORK.
- 2. RESPECT FOR PRIVACY:** DO NOT SHARE PERSONAL INFORMATION OR POST IMAGES OF OTHERS WITHOUT THEIR PERMISSION. THIS INCLUDES PHOTOS FROM EVENTS, TRAINING, OR BEHIND-THE-SCENES MOMENTS.
- 3. NO BULLYING OR NEGATIVE BEHAVIOR:** WE HAVE A ZERO-TOLERANCE POLICY FOR BULLYING OR ANY FORM OF NEGATIVITY, INCLUDING TROLLING, HARASSMENT, OR ABUSIVE LANGUAGE, EITHER ONLINE OR IN-PERSON. ANY BEHAVIOR THAT REFLECTS POORLY ON THE JUNGLE CATS COMMUNITY IS UNACCEPTABLE.
- 4. APPROPRIATE CONTENT:** KEEP CONTENT APPROPRIATE FOR ALL AUDIENCES. THIS MEANS REFRAINING FROM POSTING INAPPROPRIATE OR OFFENSIVE MATERIAL, INCLUDING BUT NOT LIMITED TO, OFFENSIVE LANGUAGE, HATE SPEECH, OR DISCRIMINATORY CONTENT TOWARDS JC OR OTHER CLUBS.
- 5. RESPECT COACHES AND STAFF:** ONLINE INTERACTIONS WITH COACHES, STAFF, AND TEAMMATES SHOULD REMAIN RESPECTFUL. IF YOU HAVE ANY CONCERNS OR COMPLAINTS, PLEASE ADDRESS THEM IN A PRIVATE, CONSTRUCTIVE MANNER RATHER THAN ON PUBLIC PLATFORMS.
- 6. HASHTAGS AND MENTIONS:** WHEN POSTING ABOUT JUNGLE CATS EVENTS, TRAINING, OR COMPETITIONS, WE ENCOURAGE THE USE OF OUR OFFICIAL HASHTAGS AND SOCIAL MEDIA TAGS. HOWEVER, WE ASK THAT ALL POSTS REMAIN POSITIVE AND IN ALIGNMENT WITH OUR VALUES.
- 7. REPORTING CONCERNS:** IF YOU COME ACROSS ANY INAPPROPRIATE POSTS OR BEHAVIOR RELATED TO JUNGLE CATS ON SOCIAL MEDIA, PLEASE REPORT IT DIRECTLY TO OUR STAFF SO THAT WE CAN ADDRESS IT APPROPRIATELY.

CONSEQUENCES OF VIOLATING THE CODE OF CONDUCT:

VIOLATIONS OF THIS CODE OF CONDUCT, WHETHER IN PERSON OR ONLINE, MAY RESULT IN DISCIPLINARY ACTIONS INCLUDING:

- A VERBAL OR WRITTEN WARNING.
- TEMPORARY OR PERMANENT SUSPENSION FROM TRAINING OR EVENTS.
- DISQUALIFICATION FROM COMPETITIONS.





POLICIES

HOT WEATHER POLICY:

AS THE SUMMER SEASON APPROACHES, THE SAFETY AND WELL-BEING OF OUR ATHLETES IS OUR TOP PRIORITY. OUR HOT WEATHER POLICY ENSURES THAT WE TAKE NECESSARY PRECAUTIONS DURING EXTREME HEAT.

CLASS CANCELLATIONS OR RESCHEDULING

ON DAYS WHEN THE TEMPERATURE REACHES 36°C OR HIGHER, CLASSES MAY BE CANCELED OR RESCHEDULED TO A COOLER TIME OF DAY TO PROTECT THE HEALTH OF ATHLETES. CLASS FEES WILL NOT BE REFUNDED IN THE CASE WHERE CLASSES ARE CANCELED DUE TO HOT WEATHER; HOWEVER, A MAKE-UP CLASS WILL BE OFFERED.

MEASURES TO KEEP ATHLETES SAFE

WE UNDERSTAND THAT EXTREME HEAT CAN BE UNCOMFORTABLE AND POTENTIALLY RISKY. TO ENSURE OUR ATHLETES' SAFETY, OUR COACHES WILL:

- REDUCE THE INTENSITY OF TRAINING SESSIONS.
- ALLOW ADDITIONAL WATER BREAKS.
- PROVIDE SPRAY BOTTLES AND REFRESHING ICY POLES TO HELP EVERYONE STAY COOL AND HYDRATED.

COMMUNICATION

IN THE EVENT OF A CLASS CANCELLATION OR RESCHEDULING DUE TO HOT WEATHER, WE WILL NOTIFY YOU AS SOON AS POSSIBLE. PLEASE CHECK YOUR EMAIL, AND OUR SOCIAL MEDIA CHANNELS, OR KEEP AN EYE OUT FOR A TEXT MESSAGE.

WE AIM TO MANAGE THE IMPACT OF HOT WEATHER BY BEING PROACTIVE IN MAKING ADJUSTMENTS TO TRAINING SCHEDULES AND ENSURING A SAFE AND COMFORTABLE ENVIRONMENT FOR ALL ATHLETES.
