****Purpose:****

****Commitment to Child Safety:****

- We are committed to providing a safe, supportive, and respectful environment for all participants. Our staff members, including coaches, admin, and volunteers, all have their WWCC and undergo reference checks and, where necessary, background checks. All our coaches receive yearly First aid and safety training for all aspects of Jungle Cats. They also receive regular development to ensure we can provide the best quality of classes.

****Appropriate Behaviour: ****

- All members, including coaches, parents, and participants, are expected to behave in a manner that is respectful, inclusive, and considerate of others. Please review the Athlete and Parent guidelines below. Any members found displaying behaviour that does not align with our guidelines and values as a club will have their position within the club reviewed.

****Child Protection: ****

- Everyone involved in Jungle Cats activities must adhere to the Australian child safe standards. Any suspicion or report of child abuse or neglect will be taken seriously and reported promptly as required by law. Please send any concerns you have to Amanda at info@junglecats.com.au

**** Communication: ****

- Open and transparent communication is encouraged. Members are expected to communicate respectfully and constructively, keeping the well-being of the participants in mind. All communication from the club will come via Email, Phone, or social media in some instances.

****Inclusive Environment: ****

- Jungle Cats promotes an inclusive and diverse environment. Discrimination, bullying, or harassment based on race, gender, age, ability, or any other factor will not be tolerated. Any members displaying will be asked to leave the school.

****Safety and Well-being: ****

- The safety and well-being of participants are paramount. Coaches and organisers will implement and enforce appropriate safety measures during all activities.

**** Physical Contact: ****

- Coaches and members must ensure that any physical contact is appropriate, consensual, and necessary for the activity. Personal boundaries will be respected.

**** Supervision: ****

- Adequate supervision will be provided during all activities to ensure the safety of participants.

**** Reporting Concerns: ****

- Any concerns or suspicions regarding the well-being of a child or the conduct of a member must be reported promptly to the designated child safety officer, Amanda Eastwood or appropriate authority. Please email info@junglecats.com.au for any concerns you may have.

****Professional Conduct: ****

- Coaches and members must maintain a high level of professionalism and ethical conduct. Athletes and parents are always expected to represent Jungle Cats positively in all environments. Any conduct that may compromise the safety or well-being of participants is strictly prohibited.
